In exercise of the powers conferred by section 78 of the Registration Act, 1908 (Act no. XVI of 1908), read with section 21 of general clauses Act 1897 (Act no 10 of 1897) and in supersession of the table of Registration Fees issued by Government notification no.S.R.976/X-550-(51)-76 Dated march 31, 1976 and amended from time to time, the Governor is pleased to publish the following table of Registration Fees which shall be effective with effect from the date of publication of the notification in the Gazette.

**TABLE OF REGISTRATION FEES**

Subject to the exceptions herein contained and remissions and reductions granted by the State Government following fees shall be charged-

When they do not so appear, a separate fee shall be levied for each person or set of persons appearing at one and the same time. (2) The duplicate or triplicate of a power of attorney presented for authentication shall be treated as a separate power and a separate authentication fee shall be charged therefore.

(a)	Search or inspection of records of one year.	10.00
(b)	Search or inspection of records of more than one year, under one application.	10.00 for every year subject to a maximum of 100.00 in any one case.
<b>Explanations:</b>		
(1) Searches or inspections made for bonafide public purposes, on the application of the Head of Government office or Courts, shall be without fees subject to the condition prescribed in Rule 348 of the Registration Manual, Part II.		
(2) Only one fee shall be charged for one search in respect of one decree irrespective of the number of judgment-debtors and

(3) When any applicant requires a search certificate to be taken up in preference to other applicants for which ordinary search fee has been paid, such certificate shall be issued on payment of extra fee of Rs.50.00 within two days of payment of the fees.

(a)	when the person to be examined is in jail	500.00

<b>Article - 8</b>		
When under section 36 of the Registration Act, 1908, application is made to the Officer or Court appointed by the State Government to issue summons, the process fee ordinarily payable on the issue and service of a summons, by such officer or Court-		100.00

For certified copy of a document pertaining to Book no. <b>Notes:</b> When an applicant requires a copy to be taken up in preference to other applications for which ordinary copying fees has been paid, he shall be charged Rs. 100 in addition to the fees paid under this article

For return or surrender of an unclaimed document which has been entered in the registers of unclaimed documents of the office of Sub-Registrar or District Registrar under Rule 196 of the Registration Manual, Part II.		50.00 for every month or part thereof during which the document remained unclaimed, subject to a

<p><b>Miscellaneous Fees:-</b> An application presented in relation to any action / relief sought under any provisions of Registration act, 1908 or for the registration of documents, different to the documents mentioned in this table hereinabove.</p>	100.00
<p><b>Exceptions:</b> (1) No fees shall be livable upon a mortgage deed executed by an officer of the Government in Civil or Military employ for securing the re-payment of an advance received by him from the Government for the purpose of constructing or purchasing a dwelling house for his own use. Similarly, on the repayment of the advance, if the borrower desires to get an instrument of reconveyance executed by the Government in his favor, no fees shall be charged. (2) No registration fees shall be leviable from displaced persons on documents relating to transfer of property, other than by public auction executed under the provisions of the Displaced persons (Compensation and Rehabilitation) Rules, 1955.</p>
